NOTICE INVITING APPLICATIONS FOR EMPANELMENT OF ADVOCATES

Employees' State Insurance Corporation (ESIC), a statutory body under Ministry of Labour & Employment, Government of India, intends to empanel advocates for representing the Employees' State Insurance Corporation before Employees' Insurance Court, District and Subordinate Courts, Magistrate Court, District Consumer Forum and other tribunals or judicial forum in Tirunelveli, Tuticorin and Kanyakumari Districts.

The practicing advocates who are registered with Bar Council of India / State Bar Council with minimum of 5 years of experience are eligible for empanelment. The qualification, experience, schedule of fees, other terms and conditions for empanelment have been prescribed in Terms and Conditions and Annexure-A, available on website www.srotirunelveli.esic.gov.in

The advocates who are on the existing panel of advocates for ESIC, Sub Regional Office, Tirunelveli are also required to apply afresh against the current advertisement, as the current panel ceases to exist with the constitution of the new panel as per the current notice. Advocates who have not been previously empaneled with ESIC are encouraged to apply. Fresh empanelment shall be considered on merit, subject to fulfillment of the prescribed eligibility criteria.

The interested and eligible advocates can send their duly filled in application (Annexure-A), along with all the supporting documents to 'Joint Director (I/C), ESI Corporation, Sub Regional Office, ESIC Complex, Salai Street, Vannarpettai, Tirunelveli– 627003'. The last date for receiving applications in the prescribed format is on or before **08.03.2026**. The applications may be sent through post or dropped in the drop box kept for this purpose in the premises of Sub Regional Tirunelveli.
